Select "Conflict" if you have a conflict on the assigned court date. A separate box will open and select why you are unavailable for the assigned

court date. After completing the conflict information the subpoena case number will turn red.

In some counties you may be redirected to an additional officer unavailability form to complete online.

Please remember to contact the prosecutor listed on the subpoena about any conflict. You are still properly served even though you indicated you have a conflict.

When the District Attorney's office updates your conflict subpoena with the new status of "Active – Conflict Acknowledged" status on a given subpoena, an email is sent immediately to your account. (Sample email below)
